 - After much discussion, it became clear that due to reporting requirements that would be the responsibility of Mid-Isle Soccer with respect to the money raised in this way, this idea is more complicated than initially thought. It was decided that a raffle license for the club is not feasible at this time and that we would revisit the idea if we have tournaments or other events in the fall.
 - Jason made a motion to table this discussion. Seconded by Jen K. Motion passed, discussion of Raffle License tabled at this time.
